WHAT'S AHEAD

SafeNetRx established the nation's first statewide drug donation repository in 2007. Our model was unproven, and showed exceptional potential, but also carried some disbelief that the pharmacy and medical community would invest in a model that repurposed what many considered waste. 2024 marks 17 years of operating our Drug Donation Repository and 23 years working in the charitable medication space. At the end of FY2024, more than 147,000 patients have been supplied with needed medicine they otherwise could not afford. \$126 million (AWP) in donated medicine has been collected, inspected, and made available to our dispensing network.

Today, the drug donation industry is entering a new phase. States across the country have taken notice of the opportunity to develop their own programs. Statewide drug donation task forces have been created, legislation is being drafted or updated, and new drug donation models are being proposed. It's an exciting time and a rare opportunity to create charitable programs to do powerful, well-intentioned work.

As we enter FY2025, the SafeNetRx vision, principles, and model remain unchanged. We are committed to developing a national drug donation system where product integrity, medication safety, and patient dignity are absolute priorities. As new opportunities emerge and others close, our commitment to these principles will remain steadfast. We are committed to growth through exemplary stewardship in the collection, inspection, distribution, and disposal of donated medicines. We are growing new partnerships with industry leaders, state agencies, academia, and providers that align with our vision for growth. Together we can build a responsible and ethical drug donation system that aims to solve medication insecurity for millions of Americans. Please join us on this journey.

OUR DONOR NETWORK

COMMITTED TO REDUCING MEDICATION WASTE AND ENVIRONMENTAL HARM

SafeNetRx relies on generous donors for a consistent supply of essential medicines needed to treat the most common chronic and acute illnesses such as diabetes, heart disease, mental illness, asthma/COPD, and cancer.

Currently, 237 long-term care pharmacies, community pharmacies, medical clinics, public health agencies, and other institutional donors offer medications to SafeNetRx from across the nation.

FY24 DONOR IMPACT

- MILESTONE: We surpassed **\$120M** (AWP) in total donated medicine since we opened our doors in 2007.
- In FY24 alone, our donors contributed more than \$21M (AWP) worth of medications.
- Prevented over **4.1M doses** of medications from entering our landfills.

This year SafeNetRx welcomed 16 new donors to our network.

OUR TEAM

PHARMACISTS, TECHNICIANS, INTERNS, AND VOLUNTEERS THAT CONTRIBUTE TO CHANGE

To ensure the accuracy of our inventory, our team records all of the necessary drug information for each unit of donated medicine that comes through our doors. This allows our partners to view our inventory in real time and order what is needed by their patients.

After an order is received, our technicians remove all protected health information and prepare orders for pharmacist inspection.

SHOUT-OUT TO OUR VOLUNTEERS!

Our process is time-consuming. We are so grateful to have an army of volunteers with huge hearts and strong hands. In FY24 our volunteers helped process:

- 201,760 individual donations
- More than **\$24.5M** (AWP) in donated medicine and supplies
- 4.1M doses of medicine


SETTING DRUG DONATION STANDARDS AND NEVER SACRIFICING PATIENT SAFETY

As one of the first drug donation programs in the country, SafeNetRx has set the bar high for drug donation product standards and has strict safety protocols.

Our team of pharmacists inspects each unit of medicine donated to ensure high product integrity, accurate labeling, and that the medication is safe to consume.

To date, SafeNetRx has had ZERO patient safety issues!

OUR PROVIDER NETWORK

COMMITTED TO SERVING COMMUNITIES STRUGGLING WITH MEDICATION INSECURITY

Our mission to serve is achieved by maintaining strong partnerships with providers and pharmacists committed to providing the highest level of care to ALL patients.

In FY24, the SafeNetRx provider network:

- Dispensed 1.6M doses of donated medicine valued at more than **\$12.9M** (AWP)
- Cared for 13,612 patients who could not afford needed prescriptions — bringing our all-time total to **147,843 patients served**

This year, we established 14 new dispensing partnerships and are always looking for more!

OUR MISSION

SOLVE MEDICATION INEQUITY THROUGH RESPONSIBLE COLLECTION AND DISTRIBUTION OF DONATED MEDICINE

At the heart of our mission are patient lives. Individuals who have fallen through the cracks of our healthcare system and desperately need assistance. We are the safety net that catches them.

We serve individuals who are unable to afford their prescribed medication, regardless of insurance status, with an annual household income at or below 200% of the Federal Poverty Level.

HEALTH SAVINGS

Research has shown charitable medication programs can reduce health system costs by 27% (\$3,161 annually per patient) and inpatient stays by 20%.¹

- SafeNetRx health system cost savings in FY24 were \$43M based on these estimates.
- On average, our patients save more than **\$200** per 30-day prescription.

- Support of clinics, pharmacies, and other healthcare stakeholders in the delivery of safe, efficient, and effective pharmacy services for underserved populations.
- Provision of training, research, and evaluation opportunities to support ongoing innovation in charitable pharmacy services.
